

#### From the Board

The November Board Meeting was held on Thursday the 12<sup>th</sup>, a week earlier than usual, in order that the Board could approve the Budget, which needed to be available on Sunday the 22<sup>nd</sup>, two weeks before December 6<sup>th</sup>, the date of the Budget Meeting, as required by our By-laws. Got that? Rev. Christine was not present. She was at the UUMA Conference in Ottawa.

The Meeting began, after the usual preliminaries, with a lucid and detailed report by Doug Whaley on the status of the Lloyd Fund and also on the state of the economy and what it might mean for the Fund and the Church over the next year or so and beyond. Perhaps the most salient piece of information is that the fund has recovered a great deal of the capital lost during the economic melt-down and now stands at around \$400,000. Disbursements will remain low for a while, as dividends have not returned to previous levels, but we are entitled to feel some optimism for the future. We should probably consider including a portion of the capital gains, but not the capital, in our revenue stream when circumstances warrant. Doug stayed for a while to answer questions from Trustees and a lively debate ensued.

After Doug left Bobbye took centre stage to present the proposed Budget. This was done in masterly (mistressly?) fashion. Bobbye explained the process and the product, explained all the spread sheets and moved acceptance of the Budget. Her Motion was approved unanimously. Bobbye gave a lot of credit to the Finance Committee, both the continuing and the new members. She gave especial thanks to Helen for her able assistance. The Board thanked Bobbye for all her hard and careful work. She indicated that retirement enabled her to spend the amount of time necessary to do the job properly.

Trustee Reports were received. Joyse said that she was preparing about 50 goodie bags of traditional treats for the Family Service. (I expect mine will include a piece of coal). Any children present can help her distribute the bags. Helen reminded us all about the collection for the Children's Aid Society Christmas family. She promised to make an announcement in Church. John suggested that a meeting for new members (of which there seem to be more than a few) to introduce them to the Church and UUism would be good idea. Rev. Christine, who I believe is in favour of such an initiative, will be consulted on her return. Bonnie moved that a Fund Raising Committee be established and the Board approved the Motion. Canadian Unitarians for Social Justice has asked congregations to support their publication. Consideration was deferred until the next meeting. It was noted that the Nominating Committee needs to start its work. Committee members are Mireya Campbell, Mariette Preyde and JohnUpcott. If you are interested in being a member of the Board or a Committee member, let one of them know. If they approach you, please give serious consideration to serving the Church in any way you believe you can.

One thing that did not occur last month was the Visioning Workshop that I discussed in the last Newsletter. A combination of illness and scheduling difficulties forced its postponement until the New Year and probably the new Board. This is an important activity and it is critical that it be done properly and with a full Board complement.

### **Social Responsibility Committee**

The Social Responsibilities Committee has so far loaned \$300 USD through KIVA: \$100 each to small enterprises in Bolivia, Togo, and Mongolia. Here is a summary of the state of the loans as of Nov. 25 made by the UU Church of Olinda Field partners were sought out who charge relatively low interest/fee rates.

#### **Financial Trustee Report**

The 2010 Budget was available to the Congregation on Sunday, Nov. 22, and everyone who did not pick up a copy then should do so before the Congregational Budget Meeting on Dec. 6, after church. Please bring your copy to that meeting so that we do not

have to print out any more copies than absolutely necessary.

During the Open Finance Meetings last spring, two issues came up. 1) The request for more transparency in the budget development process, and 2) the observation that the predicted deficits have been very different from the actual deficits at the end of the year. In response to the first issue, a formal Budget Procedure has been approved by the Board, the finance meetings this fall have been open, and new members have been actively recruited. In response to the second issue, the assumptions used in predicting income have been carefully compared to the actual income. As can be seen on the published 2010 Budget, for 2007 and 2008, the assumed income was about \$7000 less than the amount received in total offerings. About twice as much was donated per month in November and December than for the other months of the year. In the interest of increased accuracy, the total offerings in 2010 was calculated using this ratio. This resulted in a value about \$7000 higher than it would have been using the earlier assumption that the rate of giving was the same throughout the year.

Note that the total offerings have been lower by about \$3000 this year, and it is assumed that this trend may well continue into next year, given the economic climate. The Lloyd Fund transfer is also budgeted to be lower by \$3000, due to decreased pay-outs this past year from Energy Trust Funds, a situation that may not be fully resolved during 2010.

Given the tight financial situation expected to continue for at least part of the coming year, every line item on the budget was carefully scrutinized for possible reduction. For instance, the Members' Conference Expenses line was cut from \$3000 to \$1000, with the expectation that few if any members were planning to attend the CUC meeting in Vancouver next year. Since CUC will meet in Toronto next year, we hope to be able to increase this line item back to \$3000 for 2011 so anyone who would like to could go. In general, we hope very much that the financial situation faced by our church will be eased by then and that the 2009 and 2010 period will only be a temporary set-back.

When we look at the 2010 budget deficit of about \$8000, we need to realize that, what with the change in estimating income and cutting of various expenses, this number will probably be close to the deficit we will actually see at the end of 2010. The Finance Committee will be meeting next spring to discuss possible fundraising efforts, especially ones that do not involve asking for more money from the same people, as has been the case in the past. These events should also have the positive effect of spreading the word about Universalism and Unitarianism in our wider community. Anyone with any ideas about this should join us at those meetings.

Pledge cards are also due on Dec. 6. I would ask anyone who is in a financial position to do so to consider pledging an additional 20% to help us though this coming year. We are all committed to assuring that our deficits will not cause us to have to draw more from the Lloyd Fund than can be sustained. But it is also important that we continue to maintain our profile and enjoy the good fortune we have our beloved community.

Oh yes, don't forget that all donations to the church that are submitted by the Dec. 27 service will be eligible for a 2008 tax donation.
