From the Hillparson



"For those who have learned to live at the end of the road there is a vision always accomplishing itself, a vision of human perfection rising out of history and of history rising toward that goal. Faith is the assumption that the universe makes this rise possible, hope is the expectation that we can rise thither by our own powers, and love is the knowledge that we must make the ascent together." — Barrows Dunham (1905-1995) (Thank you to The Liberal Lec-tionary on Facebook for this quote)

Unitarian Universalism is what is called a liberal religious tradition but we are not all that can be called liberal religious. Some of almost every religious grouping might be called 'liberal religious' at least from inside that body, and many of those who claim a liberal view on that body might well be called heretical by many of the rest. We UUs don't have that particular problem.

We do, however, often wrestle with a problem most other religions have already resolved. Boundaries. Only within the last decade or so have UU congregations truly begun to consider that guidelines/policies should be put in place for the health of the congregation, of our tradition as a whole, as well. But mostly work within congregations is what is being given growing attention. We may each believe and affirm theological persuasions and values unique or peculiar to us, we may think what we think. What we cannot do is act on ideas we may have that will do damage to an individual, individuals, or to the congregation as a whole. Nor may we act in public in ways that get in the way of the principles and values we follow or the congregation's mission statement.

Numbers of UUs struggle with the very concept that we might have rules or boundaries and we therefore end up with occasions where someone's inappropriate behavior is left unchecked by the body of the church. Unchecked, bad behavior has too often ended up (because of both the behavior AND the not standing up to it) causing sometimes irreparable damage to the congregation. Damage that doesn't stop just because the involved leave in one manner or another. The effects of this kind of damage is generational in nature, meaning that a given church's anxieties and behaviors are framed by some long ago event, long after it has been "forgotten". Unless dealt with in the moment, or managed in the future (not the best choice) bad behavior makes a church troubled and troublesome. What is wonderful is that a great many wise and caring people have developed programs to help a congregation heal, and even better, with assistance numbers of our congregations have developed covenants for how we behave with one another. It is good that each of our congregations are part of a greater body of congregations. That we identify new challenges and work through them.

My great thanks to numbers of people who assisted in making the memorial service for Olinda's great Louise Foulds a wonderful day of memory and promise. Bill Baylis, Gypsy Carroll, Jane Innerd, Carabel Ringrose, Lori Lyons, Carol and Laurie Hylton, Trudy Ware and John Upcott. I'm sure there are others and know that your contributions are as thanked as those named. Blessings to Olinda for Louise's life having been so integral to decades of the life of the congregation.

From the Board

At its meeting on October 17, your Board as usual approved the agenda and last month's minutes, but then we noticed that minutes posted in the coffee room were almost a year old. Oops. The approved minutes of Board meetings are supposed to be posted so that the congregation can read about our deliberations and see the decisions made. Obviously, we had neglected this duty: no one was assigned the task and no one did it. Not that we have been swamped with complaints. Minutes of meetings may not make the most exciting reading, but they should be available!

Next we discussed preparations for the Memorial Service for Louise Foulds on Oct. 19. John Upcott was thanked for his fine work sprucing up the garage for the ceremony of burying ashes in the tranquility garden. It was agreed that the generous Fould's bequest should be invested with the Lloyd fund monies, but whether it would be added to the Memorial Fund or made a component of an enlarged Lloyd fund was not fully resolved. The Board also noted with pleasure that, thanks to help from Vic Spicer and Zach Showers, our website uuolinda.org can now be found in Google searches. The website is a work in progress, but at least it now has some visibility. If you have items that could be added to the site, please send them to me. The minister reported that our Facebook page seems quite successful. It is managed by Reverend Christine Hillman together with Charlotte Innerd.

Stuart Miller reported on the challenges of running religious education (RE) for children when attendance is sporadic and there is no dedicated teaching staff. If you would be willing to help and fill in on occasional Sundays when needed, please talk to Stuart. There is also a need for the return of adult RE. Reverend Hillman has much experience in this area and will work with Stuart on a plan.

Since the Board is responsible for the long-term financial viability of the church, it is not surprising that reports of the treasurer and finance trustee are always a focus of discussion at our meetings. Treasurer Peter LeClair is concerned that donations are falling behind those of the recent past. He has been holding enough cash in the chequing account that he has not yet had to ask for funds to be transferred from the Lloyd fund as budgeted. This allows the Lloyd fund investments maximum flexibility in accruing value and income. However, if he continues this practice to year's end, it will consume most of the operating fund surplus. A lively discussion ensued about the health of the Lloyd fund and how much money should be taken from it to support our operations. Last spring, in response to such concerns, the Board voted to target a reduction in the amount of the transfer in future budgets from \$33,000 to no more than \$30,000. Questions about the current state of the fund and projections about its future performance were addressed to the Lloyd Fund

Committee through its member Mariette Preyde, who was attending our Board meeting as a guest. Finance Chair Bobbye Baylis is working with her committee to draft the 2014 budget and asked for budget requests from all committee chairs.

Another important action was the Board's approval of a significant change in the focus and operation of the Committee on Ministry. Instead of acting largely as a support group for the Minister, it is to become a proactive agent for advancing the ministry of the church, supporting all members and implementing our mission statement. As such, it will perform a central role in church operations, acting objectively with clarity and transparency to gain the trust and cooperation of the congregation. A brochure describing the new role is in preparation. One of the first tasks of the committee is to design a tool for assessments of the ministry that should start soon and be repeated every year or two. The next regular Board meeting is scheduled at 7 PM on Thursday, November 21, 2013. All church members are welcome to attend.

Finance Committee Report


On Nov. 10 after church, we will have the Open Finance Meeting to decide on the 2014 Budget to be presented to the Board and then to the Congregation on Dec. 8. All members of that committee, please make a point to be there for that meeting. Committee members are Helen Moore, Doug Whaley (Lloyd Fund), Gypsy Carroll, Mireya Campbell (Lloyd Fund), Peter LeClair (Treasurer), Carol Hylton, Mariette Preyde (Lloyd Fund), John Haynes (Lloyd Fund), Bobbye Baylis (Chair), Bill Baylis (President) and Rev. Christine Hillman. Anyone else interested in the financial affairs of the church is also welcome to come. The Letter of Appeal will also be distributed on that date. It will include information from your Treasurer on your 2013 Pledge and how much you have already contributed toward that pledge, as well as information on your pledge to the Capital Campaign. Please return your 2014 Pledge card as soon as possible to Peter LeClair or myself so that we have the information for the 2014 Budget.

For the last two years we have been focussing on our historic building and have made major improvements that will assure our continuance well into the next decades. The Board is also committed to ensuring our financial sustainability with the same long-term goal in mind. In addition, the Committee on Ministry has started a new process to review and strengthen the ministry of the church. These activities may well result in changes to future budgets, but there will not yet be enough information collected nor progress in developing procedures for there to be major changes in the 2014 budget process. However, by this spring these new procedures will be in place and better information collected, and it is hoped that there can be even better communication between the Congregation and the Board on financial and other issues.
