From The Board

Welcome back!

Summer has passed – fall has arrived ... and with the changes of the seasons comes the many changes inherent in the return to the church year!

As mentioned in the last newsletter, the board of directors, trustees and others met twice throughout the summer to address the ongoing impact of COVID on the church functioning. In addition, we were able to complete a major portion of the work on the new draft by-laws that are necessary as a result of incorporation.

Moving into the fall, the board is now dealing with the following key items:

Developing an overall plan for addressing the "opening" of in-person church services which includes:

Surveying the various members of all church committees around what they would require in order to begin meeting in person, indoors;

Surveying all church members around what they would require in order to attend in person services within the church once more;

Developing a plan for how to continue with online services once in person services resume; and

Finalizing a draft copy of the new by-laws so that they can be presented to church membership for approval prior to the end of November.

As the board continues with this needed focus, the decision has been made to extend the postponement of in-person Sunday services through to December 6, to be reviewed at the November Board Meeting.

An important decision made at the September Board meeting was to restart in-person church committee meetings to be held out of doors – an important step in bringing back the face-to-face component of the Olinda community.

September through October will be a significant time period when we will be reaching out to you for your input. Please take the time to respond to any and all surveys that you may receive.

Clergy Connection

I was glad to see so many of you again at our modified water ceremony! Sharing a drink of worthy waters from a distance is a reminder that we can continue to share in our spiritual community, even while apart. Although the summer tends to have a slower pace in our church life, many in our leadership remained active in exploring new visions for our community. One of the tasks that carried on during the summer was the drafting of **new by-laws** to conform with our recent incorporation status. This involved a lot of invisible work and discussion – a process that we hope will conclude by December. As part of new visions, we will also be exploring the meaning of **covenant** and how it is central to our tradition.

Adding a sense of renewal to our church is especially timely, as we look to a year that is bookmarked by *two* **140**th **anniversaries** for us: celebrating the **founding** of our church on **November 8** this year (online), and celebrating our **church building** on September 19 next year (place to be determined!).

I find the fact that we're celebrating the anniversary of our church without the building seems oddly appropriate, since that is how our church's founders gathered 140 years ago. And it may well be possible that, by September 2021 we could celebrate the construction of our church building back in the sanctuary. For the time being, the Board has renewed the need to maintain virtual services through November of this year, at which time, we will re-evaluate our options.

As we look at our roots, I'm also excited to announce that we're invited to join an **international online service** celebrating 250 years of Universalism in North America on **October 4**.

And, by popular demand, there are *two* more **Canada-wide Sunday Services** coming up. The first one is on **November 15**, when virtual CUC regional gatherings are taking place – you can attend the stand-alone service, or explore the larger **Eastern Regional Gathering** experience over the **November 13-15** weekend. There is also **another service** in the works for **February 7**.

I also invite all of you to seek photos of departed loved ones that you'd like to share for our annual **Day of the Dead** service on **November 1**. Let me know if you'd like these photos used during the live online service only, or if you'd also like them to be part of the web version of the service.

The Board has also given the go-ahead to formalize a **Technology Team**, to offer tech support during virtual services, as well as to explore how we can make our church and its services more accessible, even after in-person services recommence. If you have experience with audio-visual and computer technology, or are willing to expand your skills, I invite you to contact Bill Baylis.

I look forward to continuing our work as a community of faith with you, as we move into a year that may offer both great challenges, as well as exciting opportunities.

Update From Property

While the congregation has been unable to visit our church since the end of March, and over the summer, your property committee has been addressing several issues.

Landscaping – The tall cedar bushes on the south side of the building constantly require trimming. Our neighbour, the Nicholls Farm, has always been very receptive to our requests for the tending of their trees. This summer he was able to remove the tops once again off the bushes, and the thin out the sides. There is now a good ten feet of open space between the church wall and the bushes. With the high bushes, our eavestroughs had become full, and John Upcott did a magnificent job cleaning them out.

Roofing – Constant maintenance is necessary to prevent small problems from developing into large damaging situations. Our roof over the second floor Archives Storage Room had developed a leak last fall. While this was partially repaired at that time, we had been advised that the shingles in this one area should be replaced.

Laurie Hylton is in the process of scheduling this work to be completed now by Unique Roofing a company that have completed the work for years.

Possible Sale of Neighbour's Property - The old red brick building north of our church, on the NW corner of the Olinda Sideroad & 5th Concession has fallen into disrepair. The property owner is also now very ill and no longer lives in the building. There had been a rumour that this corner property would go up for sale. We have been informed that the property has been taken over by the Town of Kingsville and the Heritage Foundation. This building was initially built and used as the school master's house of the Olinda Public School SS #5. The school was located across from the church which is now our parking lot. The decision to either restore the building or sell it has yet to be made. If someone did buy it and tear it down, current zoning setback requirements, and building codes, would not allow as large a new structure to be rebuilt, nor as close to the road as the old building is. Our church was, and still is interested in the property, potential for a secondary parking lot. We will keep you informed as more information is available.

The Church

Since we have been Away With Leave since our last church service on March 15, I just wanted you to know that the church building and grounds continue to exist and thrive though I am sure the building and grounds miss our presence. That may be a pretty big assumption but it is, or may be, comforting to presume we are missed.

John Upcott is now our official Property Manager, without remuneration, and daily checks the church building, systems within, and the grounds and picks up the mail. He did notice when the dehumidifier stopped working and, with consultation, purchased a new one which keeps our basement dry. He noticed that the cedars on the south side of the church were overhanging eaves troughs and very close to the windows. He called our church neighbour, Dave Nickels, who, with his family, owns the surrounding orchards (previously owned by the Fox Family of Mike Fox fame) and had planted the cedars. Dave Nickels had his workers drastically (massacre?) prune the cedars but that has provided a generous walkway to protect the church windows, eaves troughs and roof. John Upcott also noticed the weeds and grass growing out of the eaves trough above our back porch and safely cleaned the eaves trough. Derek Freeman has continued to mow and trim the grass regularly throughout the spring and summer. He does a good job keeping the church grounds looking very neat and attractive. (I wanted to use the word kempt which I assumed was the opposite of unkempt but couldn't find it in the dictionary).

Lorie Lyons has generously continued to tend the front and back gardens which she planted one and two years ago. The roses and ornamental grasses are lovely in front of the Memorial Garden and all the other flowers, plants, shrubs and trees are beautiful as well. The church gardens and lawn are well cared for and the church definitely looks as if it is, or we are, still in business and definitely not abandoned. Lorie Lyons and John Upcott keep the birds bath in the back gardens filled for our feathered friends, birds.

Neighbours watch our church in our absence. Monday I spoke with Sue Parker who was walking past the church with her little dog and had noticed we hadn't been attending church. She lives in a house on Thompson Crescent and finds the neighbourhood refreshingly quiet compared to their previous home on Pelee Island. Tina Martens, across the street, keeps an eye on the church and gave news of Mr. Hummel and his property prior to his moving to hospital and then nursing home. It is good to know others watch over the church in our absence.

In the interim we attend church services and meetings via Zoom, or read Reverend Rod's sermons online or receive them via Canada Post.

Just wanted to inform you in the event you also miss the church, the gardens and perhaps, most of all, the people including Reverend Rod and Sarah, who once upon a time attended and will again.

Membership and Publicity

During the summer your membership committee has been busy. We have been meeting virtually monthly . I am pleased to announce that Trudy Ware has joined us and that Carol Hylton is coming onto the committee as an advisor as we ramp up for our celebrations for the 140th celebrations. The original cornerstone was laid on September 21, 1881 and is still in place today. Revised By-Laws

In order to conform to the requirements of Incorporation, our By-Laws need to contain elements in the Model By-Laws for Non-Profit Corporations. The committee doing the revision (Steve Brennan, Helen Moore, and Bobbye Baylis) is adhering to the following ground rules:

- The new By-Laws must conform to the order of individual items as set out in the model by-laws for federally incorporated non-profits.
- They must conform to the Canada Not-for-Profit Corporations Act.
 For example, at the Annual Meeting the Members will elect Directors who will sit on a Board of Directors, as opposed to our present nomenclature: Board of Trustees, etc.
- All details in our present By-Laws (last amended in 2018) will be included in the revised By-Laws, except where change is required to conform to corporation rules.
- Nothing in the revised By-Laws will conflict with other documents, such as Rod's Letter of Call or the package submitted to the Federal Department for Corporations.
- These By-Laws must be approved at a special meeting of the Members and also must be submitted to Corporations Canada Innovation, Science & Economic Development, Canada. If we amend them, the same process must be followed and will cost us \$200 each time. Hence, following the advice of Margaret Kohl, the pro-bono lawyer helping us, we have kept the By-Laws as general as possible, with some details moved to a Governance Document, which will not be as difficult to modify as needed.
- Because we wanted to include as much of the original By-Laws as possible, we did include details that we felt will not need to be changed at any time in the future, at least not soon.
- The committee felt that this was not the time for a complete re-write
 of the By-Laws. That would have required assembling the various
 committees and much discussion with a wider group of people, as
 was done when these By-Laws were written in 1984. It did not seem
 feasible to do this without face-to-face meetings. So these By-Laws
 are simply a combination of the model (which in some places is
 written in legalese), our previous By-Laws, and the incorporation documents.
- We are checking with Margaret Kohl at each stage of the development of these By-Laws, so we can be assured that the end product will satisfy the government.

Special attention has been taken to assure that these revised By-Laws reflect our long-standing traditions, for which we have great respect.
