## **Clergy Connection**

With our **140**<sup>th</sup> **Anniversary service on Nov. 8**, we formally begin a year-long celebration, commemoration, and contemplation about the past, present, and future of our church. And this task includes reflection on how we relate and connect with each other – historically and in times to come. One way we do that is by considering the meaning of **covenant** and how it is central to our tradition, which continues to be one of our themes this year.

One way we've nurtured our connections this fall season, was in looking at our roots as we joined the international online service celebrating 250 years of Universalism in North America on October 4. We have another opportunity for wider connection with another **Canada-wide Sunday Service** on **Nov. 15 at 1PM**. There is also a Friday Regional Gathering on Nov. 14. Both of these are **free of charge**.

You can also attend **Saturday workshops on Nov. 14**, for which there is a sliding scale from \$20-\$100 – the **deadline** to register for that is **Nov. 10**. I will be sending a separate link where you can register.

At our Church, our Lifespan and Religious Education Committee is offering a three-week **Adult RE** program called *What Matters Now,* on **Wednesdays Nov. 11, 18, and 25** at **7PM**, with a possible extension into the first two weeks of December. This will be a time to explore some deeper questions in community and delve into the practice of covenant. All sessions will be run virtually. You can let me or Laurie Stone know if you are interested, by Nov. 6.

I attended the fall Canadian Unitarian Council Board Retreat from Sept. 30-Oct. 4, where we had extensive conversations on how the CUC can best serve our congregations Canada-wide, with a particular look at the context of 2020. One thing that has already been very visible is the number of virtual events in which we're taking part. Among these was an afternoon workshop on Congregational Conflict Levels & Intervention Strategies on Oct. 17, which I attended, along with two other Board members.

Starting on **October 21**, I will be participating in **Beloved Conversations**, an anti-racism program hosted by Meadville Lombard Theological School. I will be joined virtually by several Canadian UU ministers. Many on the CUC Board are also participating. This program spans over **four months**, including a monthly session, as well as some group conversations.

I am also set to participate in this year's **Carters Church and Charity Law Seminar** on **Nov. 5**. This is a good practice in any year, but it's particularly useful on a year like this one, as we take another look at our bylaws, and as other organizational governance questions are coming up worldwide.

I look forward to seeing you at our Anniversary service, and the other opportunities for engagement this month!

## From the By-Law Committee

When we were checking into what changes to the By-Laws would be needed to allow for electronic meetings, we also became aware of changes needed to comply with having incorporated the church. With the help of a lawyer friend of Rev. Fran Dearman, Margaret Kohr, we were directed to a website for federally incorporated nongovernmental organizations (NGO'S.) This website includes a By-Law Builder that lists the items recommended to be in the By-Laws of such organizations. With Margaret's help we were able to narrow this list down to 43 items, many of which were already in our existing By-Laws, but many needed to be added.

The resulting proposed By-Laws contain most of the items in our present By-Laws. The additional material largely covers possible occurrences that we would not have ordinarily considered and other items that we would have considered too obvious to have warranted a by-law. The only actual change is caused by the requirement by federal legislation to have the Membership elect a Board of Directors, specifying that term. Furthermore, that Board is supposed, at its first meeting, to elect the officers and create committees. In order to comply with our present practice, we are having the Nominating Committee ask potential directors which office they would be willing to take. This information would be in their report as appearing in the Annual Report. So when the Members are voting for the individual directors, they know which office that person is willing to take on. Some of the positions available are, of course, chairs of committees. We decided to allow these chairs (except for Finance) to opt out of being a Director if they want. This would relieve them of having to attend all meetings but they would have no vote. This simply adds flexibility and this option may not actually be used. We shall see.

The process we are following has involved creating proposed By-Laws using the Ground Rules listed in the Newsletter. This draft was shown to the Board and a few other individuals, then modified per their suggestions. This draft has been submitted to the Board for further review. The by-laws as approved at the Nov. 12 Board meeting will be distributed to the Members for their comments, with the hope that they can be approved at a Congregational Meeting on Dec. 20, allowing for a full month of interaction with the Members. If it transpires that more time is needed, this approval date can be delayed; Margaret Kohr has assured us that our present By-Laws are adequate for a newly incorporated NGO. But the sooner we can take care of this requirement, the better, particularly as the new By-Laws allow electronic meetings, something that was not even in our long-term plans back in 2018, the date of our last amendment!

## **Ground Rules for Proposed By-Laws**

In order to conform to the requirements of Incorporation, our By-Laws need to contain elements in the Model By-Laws for Non-Profit Corporations. The committee doing the revision (Steve Brennan, Helen Moore, and Bobbye Baylis) is adhering to the following ground rules:

- The new By-Laws must contain the individual items as set out in the model by-laws for federally incorporated non-profits, at least those items recommended by Margaret Kohr, the lawyer who had also helped Toronto First UU.
- They must conform to the Canada Not-for-Profit Corporations Act. For example, at the Annual Meeting the Members will elect Directors who will sit on a Board of Directors, as opposed to our present nomenclature: Board of Trustees, etc.
- All details in our present By-Laws (last amended in 2018) are included in the new By-Laws, except where change is required to conform to corporation rules.
- Nothing in the new By-Laws conflicts with other documents, such as Rod's Letter of Call
  or the package submitted to the Federal Department for Corporations.
- These By-Laws must be approved at a special meeting of the Members and also must be submitted to Corporations Canada Innovation, Science & Economic Development, Canada. If we amend them, the same process must be followed and will cost us \$200 each time. Hence, following the advice of Margaret Kohr, we have kept the By-Laws as general as possible, with some details moved to a Governance Document, which will not be as difficult to modify as needed.
- Because we wanted to include as much of the original By-Laws as possible, we did include details that we felt will not need to be changed at any time in the future, at least not soon.
- The committee felt that this was not the time for a complete re-write of the By-Laws. That would have required assembling the various committees and much discussion with a wider group of people, as was done when the present By-Laws were written in 1984 (last revision, 2018.) It did not seem feasible to do this without face-to-face meetings. So these By-Laws are simply a combination of the model (which in some places is written in legalese), our previous By-Laws, and the incorporation documents.
- We are checking with Margaret Kohr at each stage of the development of these By-Laws, so we can be assured that the end product will satisfy the government.

Special attention has been taken to assure that these revised By-Laws reflect our long-standing traditions, for which we have great respect.

## **Finance Trustee Report**

Our 2020 Budget preparations are under way and the Finance Committee will be approving the Budget on November 8. This budget is always based on the actual expenses of the past year and on our best estimate of the expected income in 2021. Office expenses were higher due to mailing out sermons and newsletters, but email and Zoom do not cost us much. Thankfully you have still been very supportive with cheques and e-transfers in spite of not being able to meet at the church.

Early in November you will be receiving a Letter of Appeal, requesting that you fill out a pledge form for 2021. You might consider sending the information to Helen via email or giving her a call if you do not want to get the pledge form to a mail box.

Since we are still not close to being able to meet in person for services or events, we have started brainstorming about fundraisers that can be done "remotely." Your ideas are welcome!

## **Apple Crumble**

It's fall once again and when it's cool outside, the leaves crunching under my feet, I begin to crave a warm traditional dessert that reminds me of home and family. Here's a time honoured recipe for Apple Crumble.

Optional Variation: Add 1/2cup raspberries to the apples. The berries provide a lovely pink hue to this dessert.

Preheat oven to 350 F.

Lightly grease a 9 x 9 baking dish with butter or margarine.

Ingredients: For Fruit Filling

4 cups sliced and peeled apples

1 Tablespoon Lemon Juice

1/2 cup sugar

2 Tablespoons Cornstarch

#### Ingredients for Crumble Topping

1/2 cup all purpose flour

3/4 cup sugar or sugar free substitute

1/2 teaspoon Cinnamon

Pinch salt

1/2 cup rolled oats

6 Tablespoons cold butter cut into pieces

Method: Combine Flour, 3/4 cup sugar, cinnamon, salt and oats. Cut in butter, keep cold until ready to use.

In a separate bowl: Combine apples, lemon juice, 1/2 cup sugar and cornstarch. Put fruit in bottom of baking dish, top with Crumble Topping, and bake for 1 hour.


