#### **Report from the President**

It has been a busy month for our church. Preparations for our first online fund-raising aUUction on May 29 are coming together nicely. The next newsletter will list updated items for both the silent and online aUUctions. All non-perishable live aUUction items are now at either Toni's or Carmen's. Much thanks to the volunteers working hard to make it happen.

The board meeting on Thursday, May 13, addressed several topics including the opportunity to acquire the property across the street from the church at 1520 County Road 5. The board considered whether acquiring the property would benefit the church, e.g. for use as a parking lot. The board deferred the matter to a special board meeting on May 20 to gather additional information. Many thanks to Stuart Miller for his thorough and

capable research (See photo.) It seems unlikely the property will be offered for sale at an attractive price given that there is room to build a large house on it, 38 feet x 116 feet, after including the required setbacks (SB on photo.) Furthermore, putting a parking lot on the property would be expensive and would also incur ongoing maintenance costs for additional parking capacity we don't yet clearly need. The board declined to take immediate action but may discuss the question further at the June meeting.

#### **Clergy Connection**

May is always a busy time for our denomination in Canada. This past week included the Canadian Unitarian Council's Annual General Meeting, a gathering of the UU Ministers of Canada (UUMoC), and the CUC's Annual Conference, which included our national Sunday service. You may have seen a few folks from Olinda in composite choirs during the service!

The many goings-on this past week meant I clocked over 50 hours of Zoom time! It was a busy and rewarding time. Some of my time with colleagues at UUMoC included professional development with the Rev. Dr. Natalie Fennimore, who offered us strategies for better understanding how we frame our work toward radical inclusivity and justice, among other valuable insights.

The CUC AGM was an eventful time, as much support was shown for the adoption of an 8<sup>th</sup> Principle. Following a recommendation from the Dismantling Racism Study Group, a delegate's spontaneous motion from the floor proposed the immediate adoption of the principle. While this motion had overwhelming support, it was later determined that introducing a motion at such late stage was inconsistent with the CUC's by-laws, which means the principle has not been formally adopted – yet. Leadership at the CUC have now suggested a timeline for congregations to discuss it, and allowing delegates to ensure that they have their congregation's support. We'll have some time to do this work, leading to a special meeting at the end of November.

If you're curious about the 8<sup>th</sup> Principle and the process toward adopting it, the CUC's "A Way Forward for the 8<sup>th</sup> Principle Process" will be helpful in addressing most, or all, of your questions.

#### **Going Squirrely**

Two thousand and twenty was the year I went completely "squirrely", to coin a phrase, and not just because of the Pandemic and its impact on literally every facet of my life, but because of The Squirrels. The Squirrels and I have had an on-off, love-hate relationship, for 4+ decades now, ever since I first started seriously feeding The Birds.

Anyone who feeds birds, and has bird feeders, knows you can't feed The Birds without also feeding The Squirrels... and, depending on where you live, all sorts of other "uninvited guests" arrive for eats, such as racoons, skunks, deer, porcupines, mice, rats, voles, moles, wild boars, and even bears. A veritable buffet for all of God's Critters. As you might imagine, as a Rookie Bird Fan, I was being eaten out of house and home of bird seed, sunflower seeds, special seeds like thistle, suet and all the other tasty snacks that money can buy (and only someone with a pretty good job can afford). So, I began to do some serious, and I do mean serious, research on the behaviour of my Arch Enemy, The Squirrels, so I could "one-up" them in my Bird Feeding hobby. The first strategy I discovered in reading, and then implemented, was to give The Squirrels their very own super treats in an area removed from the other bird feeders. I bought several special feeders designed to hold various sizes of dried corn cobs, supposedly one of their favourites, and bags of dried cobs to stock the new feeders for Them. This strategy worked for a few weeks, until some smart Leader Squirrel said to his buddies, "let's eat dinner Here (the cobs), and then go over There for dessert" (the bird feeders)! In no time, however, the corn cobs began to be "dessert" instead of the main meal, only supplementing the contents of the bird feeders. Squirrels 1, Judy 0. One of the next wicked strategies I found in my research, was to be sure ALL your feeders were atop of at least six-foot, heavy metal poles, placed solidly in the ground. Once the feeder was adequately secured, a round metal "squirrel baffle" was applied to the pole UNDER the feeder, to prevent The Squirrels from somehow getting up the pole, and around and over the baffle into the feeder. However, someone forgot to tell The Squirrels, they were NOT to climb the poles and then eat in the feeders! Squirrels 2, Judy 0. Then I read the REAL answer to my dilemma, and something that would offer The Squirrels a REAL challenge. The advice was to slick down the pole of each feeder, with Motor Oil, from the bottom up. I was told NO squirrel was going to get up the pole, as their paws would immediately hit the oil on the pole, and their greasy little paws would make them slide down. So there! I perched myself in a comfortable chair by the dining room window that looks out on all the feeders, equipped with my binoculars. Let The Games begin! For awhile They lulled me into a false sense of security by trying to jump onto the oiled pole and grasp on, only to slide down to the ground, time after time, Squirrel after Squirrel. Then Squirrel Advisory Committee met, and after a good laugh, decided to stop toying with me, and let The Games really begin. Perched on my chair, watching a line-up of "Dumb Squirrels" jump from the ground near the pole only to be foiled. I was chuckling away, when one Squirrel (probably a female) turned around and gave me The Look...and proceeded to back off from the pole about three feet and then run at it. Round One, slipped down; round two, slipped down, but on round three She moved back from the pole about six feet and jumped up the pole above the area where I had so carefully dosed it with the oil, held on, looked back at me, and climbed up the rest of the pole, around the baffle, and into the feeder. Squirrels 3, Judy 0.

#### Going Squirrely, cont'd

Did I learn my lesson with the Squirrels? Last Spring I decided to return to another hobby that I had enjoyed over the years, which had produced an abundance of fresh yummy produce, Container Gardening. I planted around 15 large containers raised up on bricks, with various varieties of tomatoes, including Beefsteak and Grape tomato plants, as well as another 6 or so pots of sweet pepper varieties. I had early varieties, mid-time and later varieties. Also a few pots of potatoes from seedlings, lettuce and radishes, and about eight 3 ft plastic window boxes, raised on saw horse, with green and yellow beans. As the season began last year, my Archs, The Squirrels, basically remained focused on the feeders, and left my veggies alone. However, as time went by, even with covering them with netting, The Squirrels got wind of my new hobby, and day after day, got in and ate more and more of my vegetables, often before we even had a taste! Over just a few weeks, They ate and destroyed EVERY SINGLE ONE of my vegetable plants, as well as about eight beautiful hanging red Geraniums! As a last resort, I Googled what I should try to at least keep them out of my Geraniums, as they were eating not only the buds, but digging into the hanging pots and eating all of the roots. Between Google and friends, I discovered, and tried, several "natural home remedies", including putting lemon wedges and red pepper flakes in the pots (not at the same time!), and finally the "piece de resistance", spraying diluted apple cider vinegar on the root areas. That was the final straw. The Geraniums died NOT from The Squirrels, but from the apple cider vinegar spray... and the yard smelled awful for days! Squirrels 4+, Judy 0.

Stay tuned for the dastardly plot I have devised to defeat The Squirrels for this season. Hoping for Judy 10, Squirrels 0! Watch for Part Two coming soon (with pictures) in this Newsletter!

#### Report to the UU Church of Olinda on the CUC's AGM

When I volunteered to be a delegate for our church to the Annual General Meeting of the CUC on May 8, 2021, I anticipated mainly the usual boring meeting, approving rather perfunctory resolutions and electing qualified members to continuing positions on the CUC board and its committees. But it turned out to be something else entirely! It was an exciting meeting full of drama and emotion, and I thank the Olinda Board and CUC for giving me an opportunity to participate.

Only two resolutions requiring votes had been placed on the agenda. One set uniform dates for setting parameters for the Annual Program Contribution and the other set priorities for action by the CUC in 2021-22. Both seemed good choices and were in fact approved. In addition, proposed changes to the Board of the CUC were approved, including the extension of our minister, the Reverend Rodrigo Emilio Solano-Quesnel, on the Board for a second term of three years. In addition, several reports were received, including the final report of the Dismantling Racism Study Group (DRSG), which among other points recommended the adoption of a new UU 8<sup>th</sup> principle to counter racism.

According to CUC Bylaws, any motion or resolution brought before the AGM that is not on the agenda is out of order, and no motion for an 8<sup>th</sup> principle had been officially planned. Nevertheless, a delegate moved that operating procedures be suspended so that the AGM could vote on an 8<sup>th</sup> principle now. Suspension of the usual procedures is not debatable and requires a 2/3 vote. I assumed it unlikely to be successful. However, there was strong support for a new 8<sup>th</sup> UU principle, and the motion to suspend procedures was approved by an electronic hand count of 61 out of 84 delegates. The motion to adopt an 8<sup>th</sup> principle was then brought to the floor. It read, "We, the member congregations of the Canadian Unitarian Council, covenant to affirm and promote: "individual and communal action that accountably dismantles racism and other oppressions in ourselves and in our institutions."

This placed delegates like me in an awkward position since we had not considered the question at our church. At the AGM, speakers alternated for and against the motion, with pro speakers urging support so that an 8<sup>th</sup> principle could be implemented immediately. Those speaking against the suspension were generally not opposed to the proposed new principle but were concerned about procedure: had there been enough time to fully consider its consequences and wordsmith its formulation? It seemed an historic moment for the CUC. Wide support for the new principle was evident, and its text could always be adjusted at future AGMs. I voted for the suspension of the rules and for the adoption of the proposed 8<sup>th</sup> principle and hoped this represented the sentiments of our members.

This was a bold action by the AGM, but evidently inconsistent with the CUC's by-laws. The board reviewed the procedures and CUC bylaws after the meeting and concluded they had acted too hastily. The bylaws should have taken precedent. Their president, Margaret Wanlin, drafted a letter to CUC members, confirming support of the proposed principle but apologizing for the procedures followed, and proposing a special meeting on November 27, 2021, for more deliberate consideration of the proposed eighth principle after member congregations have an opportunity to fully discuss its implications with their members. Full details will follow soon from the CUC.

#### **Property Committee Report**

Now that Spring has arrived, the Church is scheduling maintenance and repairs. The roof leak that has been plaguing us intermittently over the last couple of years will now be repaired.

Local company Fehrway Roofing has submitted a quote that the Board has approved. Abe has confirmed that mid June, this summer, his crew will replace worn shingles at the main roof peak, and around the chimney, and seal and provide flashings in these areas.

Our neighbouring property to the north has been cleared of its old building, and the file has been closed by the Town and is now in the hands of the Province of Ontario. Potentially it will be put up for sale. The Board is interested in this property, and is currently investigating its details and how the church could utilize the extra area. #### **Governance Document Committee Report**

This document is envisioned to be a source of information on the responsibilities of officers, committees, and committee chairs. It will supplement the By-Laws, giving details too specific and perhaps too flexible to be included in the By-Laws that require Congregational Meetings to amend. The amended By-Laws then must be submitted to a Federal government office, with a cost attached. Some material in the 2018 By-Laws was transferred to the Governance Document for this reason. This committee will be collecting information and writing up additional "job descriptions" and procedures for inclusion in this document.

As a start to gathering information, emails were sent out to many committee chairs (including past chairs) requesting information they believe should be included in the Governance Document. Any existing documents will be useful, such as job descriptions and reports passed from retiring chairs to new chairs. Several chairs have responded, providing a start on this phase of preparation of the Governance Document.

One procedure that should possibly be developed by this committee relates to how chairs of the various committees are chosen. Presently the Finance and other operating committee chairs are appointed by the Board annually, and some other committees have rotating chairs chosen by the committees themselves. But other committees have no procedures. Should there be a general procedure for a yearly selection of their chairs, to use if the committee desired? This would not limit how the committees would function or their chairs be chosen. They might chose not to have a chair at all.

Another possible procedure that has been suggested concerns solicitation for other groups or individuals. Other situations may call for procedures, simply to prevent problems in the future. Suggestions are welcome!

At present the committee consists of Bobbye Baylis, John Upcott, Laurie Hylton and Jane Innerd. We request one or two more volunteers. Incidentally, the final committee composition has to be approved by the Board, per our new By-Laws.
